Statutory Auditors have modified their conclusion on the audited financial results (Standalone and Consolidated) for the quarter & half year ended September 30, 2022 as under: (i) The Holding Company has not carried out impairment assessment of one of the ENA plants as required by Ind AS 36 'Impairment of Assets' though there is an indication of impairment. (ii) PunjabExpo Breweries Private Limited ("PunjabExpo") wholly owned subsidiary of the Company, has incurred net loss during the quarter and due to accumulated losses, the net worth is negative. Despite adverse financial conditions, the Company has not recognised provision for impairment in equity investment of Rs. 2,680.40 lacs and loans & advances given of Rs. 3,782.97 lacs to PunjabExpo as required by Ind AS 36 'Impairment of Assets'. (iii) The National Company Law Tribunal ("NCLT") has ordered for liquidation of Prag Distillery (P) Ltd. ("Prag"), wholly owned subsidiary of the Company. However, the Company has not made impairment provision for equity investment of Rs. 1,543.35 lacs in Prag as required by Ind AS 36 'Impairment of Assets'. (iv) Prag has incurred capital expenditure of Rs. 10,021.89 lacs as at September 30, 2022 on expansion project ('the Project') grouped under the head capital work in progress. Work on the said project has been suspended and has not been completed since many years. Further the Building, Plant & Equipment of the Company has remained idle due to Plant shutdown. The Company has not tested the said project, building, plant and equipment ('Tangible assets') for impairment loss as per Ind AS 36 - Impairment of Assets. (v) Prag has unsecured overdue trade receivables of Rs 586.55 lacs and deposits of Rs. 182.05 lacs from Andhra Pradesh Beverage Corporation Ltd and unsecured advances given to suppliers of Rs. 210.99 lacs which are long overdue and doubtful of recovery. The management has not considered any provision for allowance on doubtful trade receivables (expected credit loss), deposits and advances though it is long overdue. # सर्वोच्च न्यायालयाची केंद्रावर नाराजी

## न्यायाधीशांच्या रखडलेल्या नियुक्त्यांवरून ताशेरे

नवी दिल्ली : वरिष्ठ न्यायालयांमधील न्यायाधीशांच्या रखडलेल्या नियुक्त्या ही स्वीकाराह बाब नाही, अशा शब्दांत सर्वोच्च न्यायालयाने केंद्र सरकारची कानउघाडणी केली. नियुक्त्या रखडवणे म्हणजे ज्याचे नाव सुचवले आहे, त्याला माघार घेण्यास बाध्य करणारे 'उपकरण' झाले आहे, असे न्यायालयाने म्हटले आहे.

सर्वोच्च न्यायालयाच्या न्यायवृंदाने (कॉलेजियम) एखादे नाव पुन्हा पाठवले, तरीदेखील नियुक्ती केली जात नसल्याचे निरीक्षण न्यायालयाने नोंदविले.

बंगळूर वकील संघटनेने अमित पै यांच्यामार्फत दाखल केलेल्या याचिकेत नियुक्त्या रखडणे म्हणजे 'जाणूनबुजून अवज्ञा' असल्याचा आरोप केला आहे. त्यावर न्या. एस. के. कोल आणि ए. एस. ओक यांच्या खंडपीठाने केंद्रीय विधि सचिवांना नोटीस बजावली आहे.

### सर्वोच्च न्यायालयाच्या निकालावर आक्षेप

## पालघर साधू हत्याकांड सीबीआय तपासाबाबत १५ नोव्हेंबरला सुनावणी

महाराष्ट्रातील पालघर जिल्ह्यात एप्रिल २०२० मध्ये जमावाच्या मारहाणीत दोन साधू आणि त्यांच्या वाहनचालकाचा मृत्यू झाला होता. याप्रकरणी केंद्रीय गुन्हे अन्वेषण विभागाकडे (सीबीआय) तपास देण्याच्या मागणीसाठी दाखल करण्यात आलेल्या याचिकेवर सर्वोच्च न्यायालयात १५ नोव्हेंबर रोजी सुनावणी होणार आहे. महाराष्ट्र सरकारने नुकतीच केंद्रीय तपास यंत्रणेद्वारे या प्रकरणी तपास करण्यास अनुमती दिली होती.

मुख्य न्यायाधीश धनंजय चंद्रचूड आणि न्यायमूर्ती हिमा कोहली यांनी जनहित याचिकाकर्त्यांना सांगितले की, राज्य सरकारने या प्रकरणी 'सीबीआय' तपासासाठी या अगोदरच परवानगी दिली आहे. त्यामुळे या याचिकेत आता काही शिक्कक नाही. यावेळी मुख्य न्यायाधीशांनी १५ नोव्हेंबर रोजी सुनावणी करणार असल्याचे स्पष्ट केले.
