1. On June 28, 2024, Mr. Pradeep Kumar Kheruka (Promoter), along with Mrs. Rekha Kheruka and Mrs. Kiran Kheruka (both part of the Promoter group) [Sellers], sold a total of 31,45,600 equity shares, in the open market. However, as of June 30, 2024, the sale of these 31,45,600 equity shares by the Promoter and Promoter Group was pending settlement. Consequently, as of June 30, 2024, these shares continued to be reflected under the respective Sellers' names in the Depositories' records. Accordingly, the shareholding pattern as of June 30, 2024, did not reflect the sale, as it was based on the information received from the Depositories.

The current shareholding pattern as of September 30, 2024, reflects this sale, resulting in a decrease in the shareholding of the Promoter and Promoter Group.

Furthermore, 1,16,578 equity shares were allotted to eligible employees during the quarter ended September 30, 2024, following the exercise of their stock options. Therefore, the total paid-up share capital of the Company has increased and consequently, the Promoter and Promoter Group's percentage holding has reduced proportionately.
